### What is CAS?

**CAS Strands** 

- **Creativity**: exploring and extending ideas leading to an original or interpretive product or performance (develop one's mind)
- Activity: physical exertion contributing to a healthy lifestyle (exercise)
- **Service**: collaborative and reciprocal engagement with the community in response to an authentic need (give of oneself)

# Finding the WHY in CAS

Students should:

- enjoy and find significance and meaning in a range of CAS experiences
- purposefully reflect upon those experiences
- identify goals, develop strategies and determine further actions for personal growth
- explore new possibilities, embrace new challenges and adapt to new roles
- actively participate in planned, sustained and collaborative CAS projects
- understand they are members of local and global communities with responsibilities towards each other and the environment.
- strengthen and extend personal and interpersonal learning.
- enable the demonstration of the IB learner profile attributes in real and practical ways, grow as unique individuals, and to recognize their role in the world in relation to others.


Why and how could these responsibilities expand your understanding of the world?

### **CAS Elements**

Experiences – Participate in a specific event involving one or more CAS strands
Project – Plan and complete a collaborative month-long experience
Portfolio – Provide evidence of CAS experiences on Managebac
Reflections - Document what you learned about yourself based on the experience

# How to participate in a CAS Experience?



# The 5 CAS stages - IPARD

- 1. **Investigation** Decide on an experience in which you will create, be active, or serve (or a combination). Post on Managebac and wait for Mrs. Riddle to approve it.
- 2. **Preparation** Plan, organize, create a timeline, determine at least one learning outcome to the experience, decide on a supervisor
- 3. **Action** Do it! Make it happen. When finished send your supervisor an evaluation form
- 4. **Reflection** (ongoing before, during, and after) What did you learn about yourself? Post on Managebac.
- 5. **Demonstration** post on Managebac make explicit what you did and what you learned

## **Writing Reflections**

Some things to consider

- What did you learn about yourself (strengths and/or growth areas)?
- How did you grow?
- How did you feel about the experience?
- Limit narration (telling what you did, this is already known)
- What questions do you now have?
- Length 4-5 sentences (or more if inspiration strikes)

How could the reflection process help you with college admissions essays?

## The CAS Project

- Must include at least one of the 3 strands of CAS
- Must include at least two students working together
- Must demonstrate sustained collaboration
- Must demonstrate a significant, ongoing commitment
- Must last a minimum of one month from planning to completion

# Who should be a CAS supervisor?

CAS supervisors should:

- be familiar with elements of the CAS program as applicable
- be responsible for your safety and risk management procedures
- provide you with guidance, support, and feedback on the CAS experience
- encourage reflection
- comment on your engagement with the CAS experience if required.
- Supervisors can be a teacher, coach, parent, community liaison, pastor, etc.... (they must be over 18 years of age).

## The CAS Coordinator and IB Director Need Examples!

- Creativity Examples: active involvement in a school club, vocal/chamber choir/school band/jazz band, school play/drama club, art/music/dance lessons, cooking classes, martial arts, creative writing/planning process
- **Activity Examples**: school teams, intramural activities, community sporting activities, yoga/walking/working out/hiking, a service/creativity activity with a physical component
- **Service Examples**: student council, fundraising/awareness campaigns, volunteering at children's camps, hospitals, seniors' homes, homework clubs, volunteer tutoring, Red Cross, Cancer Society, Habitat for Humanity, Fundraising for marathons, telethons, etc.
